



The SSY Pacific Capesize Index climbed by 173 points week-on-on-week to 8,586. There was a \$0.65/t rise in the W.Australia-China iron ore spot voyage rate to \$8.80/t, while the round-voyage rate increased by \$2,000/day to \$11,150/day.
