# **New Building**

In tankers this week, Fairfield Chemical Carriers declared two optional 26.3k dwt Stainless Steel Chemical Tankers at Fukuoka Shipbuilding. The vessels will deliver within 2024.

In dry bulk, Yangzi Mitsui (YAMIC) announced contracting two firm 66k dwt Ultramaxes for Lepta Shipping, with delivery slated for 2H 2024.

In gas carriers, it has been reported that CSSC Jiangnan took orders for two firm plus two optional 99k CBM VLEC's for Pacific Gas Carriers, with the firm vessels expected to deliver in Q3 and Q4 2025. Hyundai Samho announced contracting a firm 174k CBBM LNG Carrier for an unknown owner, understood to be clients of TMS Cardiff, with the vessel set to deliver in 1Q 2026.

In the ferry market, Holland Shipyards announced contracting two firm plus two optional 60-car autonomous electric Ferries for Trafikverket Farjere, with the firm vessels expected to deliver within 2024.

# Recycling

#### Eyes on Dubai!

Another quiet week has been witnessed in the recycling industry with the lack of available units continuing to frustrate the recyclers.

The Bangladeshi domestic steel market inches up day-by-day this week which should see some increase in price indications, however sentiments of the actual recyclers remain weak largely due to the L/C issues which prevails in the country for the opening of the Letters of Credit with, still only a certain number of end users (recyclers) able to open L/C's with a higher value.

India remains sluggish with plate prices stable and whilst there is demand, price levels are expected to rise on the back of emptying recycling yards at Alang.

The situation in Pakistan appears to be improving following the devastating floods that hit most of the country and the currency slightly strengthened against the U.S. Dollar. However, these recyclers are unable to compete at this current time with their counterparts from Bangladesh and India.

All and sundry from the Ship Recycling world (recyclers/breakers, cash buyers, brokers), Ship Owners, Environmental groups amongst other business colleagues, will be congregating in Dubai next week for a return of the Annual Tradewinds Ship Recycling Conference. It will be interesting to see first-hand the continuing improvements from the recycling destinations and whether any further regulations have, or can be, implemented.

With all industry players gathering in one area, it usually helps to stimulate the marketplace as has proven to be the case in previous gatherings and return some positive impact on the scene, however this year may be different to previous years.
